For nearly 2 decades, this Dojo has made its mark on the community and has become a safe space for the 250+ weekly students who actively participate in the courses. Located in Omaha, this martial arts studio offers Karate, Tae Kwon Do, in group and private settings for all ages. They have a large enough space that can hold up to 70 kids at a time! The well-versed staff include a Program Director, a Marketing Director, 2 Sensei's and 5 teachers. The current owner has structured this business to allow him to be a passive owner who reviews payroll twice a month and does 1 in-person visit a month, all day-to-day operations are performed by the well-trained staff. The owner is selling this business because he has moved out of the state. Each teacher holds a title in their respected martial art and goes above and beyond by encouraging their students to develop characteristics that they can use throughout their day-to-day life while fostering a safe space for them to be themself. A great growth opportunity is to offer self-defense classes and promote it as a "girls' night out" event!

With a purchase price of **\$570,000**, this business is primed and ready for a new owner to step in and reap the benefits of an absentee opportunity. A 10% down payment of \$57,000 returns \$146,153 in the first year after debt payments! Seller has offered a transition period of 1 year and in order mitigate the risk and to show vested interest in the continued success of the business, he has offered to carry 15% of the purchase price. Included in the purchase is \$35,000 in Equipment and \$73,000 in studio improvements. The current marketing strategy consists of a social media presence and can be seen as an opportunity for growth.
